The Silver Spur Rodeo Vendors Chairman reserves the right of placement of all booths, excluding national and local sponsor booths.* A 50% deposit will be required at time of application for booth space reservations. *All balances are due in full no later than February 6, 2017. No vendors will be allowed to setup with an outstanding balance.* A 10% discount will be given if full payment accompanies application.
